- 1 The Tiblow Days Festival and Smokin' on Oak BBQ Competition will be held in downtown Bonner Springs, Kansas on August 18-19, 2017 and is hosted by the Bonner Springs-Edwardsville Area Chamber of Commerce.
- 2 All BBQ Teams, members, and guests who submit their registration are agreeing to abide by the Rules, Regulations, & Information as set forth in this document. This document is attached to all BBQ Registration Forms and can be found online at www.bsedwchamber.org.
- 3 Full payment must be made at the time your registration is submitted. Application is not transferrable to another team and space is not held.
- 4 Tiblow Days and Smokin' on Oak is held rain or shine. No refunds will be given.
- 5 Reservation deadline is August 4, 2017 and/or limited to the first 41 teams, whichever comes first for all BBQ Team Registration.
- 6 Late fee of \$25 will be added to competition fee if received or postmarked on or after August 4, 2017
- 7 Malt Beverages are allowed in the designated confines of the BBQ area. All city and state liquor laws will be adhered to by teams and guests and will be enforced by city law enforcement.
- 8 We strive to maintain a family friendly and enjoyable atmosphere during Tiblow Days. The Tiblow Days Festival Committee reserves the right to require teams to limit inappropriate language, remove inappropriate items, etc. to the Festival.
- 9 Smokin' on Oak BBQ Competition is a sanctioned competition by the Kansas City Barbecue Society (KCBS)
- 10 Total Prize Money for Smokin' on Oak will be \$3,500. Cash prizes, trophies, and ribbons are awarded in four categories; Ribs, Chicken, Brisket, and Pork.
- 11 Acceptance of BBQ Teams is at the sole discretion of the Bonner Springs-Edwardsville Area Chamber of Commerce and/or the Tiblow Days Festival Committee.
- 12 BBQ Teams are not allowed to use personal generators. One plug is 110 volts, there are no 220 volt outlets available.
- 13 BBQ Team placement is at the sole discretion of the Bonner Springs-Edwardsville Area Chamber of Commerce, Tiblow Days Festival Committee, and/or the City of Bonner Springs.
- 14 There will be a \$35 NSF fee charged for returned checks. This fee, plus the full fee must then be paid in cash or money order before application deadline in order to reserve space. During this time, space will not be held.
- 15 The Bonner Springs-Edwardsville Area Chamber of Commerce, Tiblow Days Festival Committee, and/or the City of Bonner Springs are not responsible for any lost, damaged, or stolen items; or responsible for accidents, injury, or illness.
- 16 BBQ Teams shall keep their space clean of litter and trash throughout the festival. Teams will need to provide their own trash bags and dispose of their trash on a regular basis.
- 17 The Bonner Springs-Edwardsville Area Chamber of Commerce, Tiblow Days Festival Committee, and/or the City of Bonner Springs is unable to assist with loading, unloading, setting up, etc.
- 18 Each team must be self-contained; there will not be any walk around room between your space and the space next to you. Trailers, tables, items, coolers, grills, etc., will need to fit in your designated space.
- 19 No vehicles are allowed inside the festival area during designated hours. Teams bringing vehicles onto the grounds or exiting without permission from appropriate personnel may face forfeiture of space immediately and future festival years. Due to the close configuration of teams, vendors, and pedestrian traffic, this will be strictly enforced.
- 20 BBQ Teams are purchasing space at Smokin' on Oak. The BBQ area is on pavement, although teams should plan for the possibility of some grassy areas.
- 21 BBQ Teams will receive additional information approximately one week before the event via email. Team location will be given at check-in only. Teams are not permitted to set up their equipment outside of the designated setup times.
- 22 Checks and money orders should be made payable to Tiblow Days and mailed to BSEDW Chamber of Commerce, PO Box 548, Bonner Springs, KS 66012. Cancelled checks will serve as your confirmation.
- 23 A deposit of \$100 will be accepted to reserve a teams entrance. The remaining fees are due no later than August 4, 2017. Deposit is non-refundable and non-transferable. A late fee of \$25 will be accessed if balance is paid after August 4, 2017.
- 24 Questions should be directed to the Bonner Springs-Edwardsville Chamber of Commerce Office. The months leading up to the festival are busy with meetings and preparation, so the preferred method of contact is email (info@bsedwchamber.org). Please allow 24-48 hours for calls to be returned (913-422-5044).
- 25 This document supersedes any verbal or written commitments previously made for the BBQ Competition.
- 26 The date the Chamber office receives completed registration and full fees or date of post-mark will be the date of receipt.
- 27 Each team is required to have a Class B Fire Extinguisher at their area.
- 28 *Waiver of Liability: In consideration of your accepting this entry, I, the undersigned, intending to be legally bound, hereby, for myself, my heirs, executors and administrators, waive and release any and all rights and claims for damages I may have against the Kansas City Barbecue Society (KCBS), KCBS Representatives, Smokin' on Oak BBQ Organizers, the City of Bonner Springs, the Bonner Springs-Edwardsville Area Chamber of Commerce, the USD 204 Education Foundation and their representatives, successors and assigns for any and all injuries suffered by me. Further, I hereby grant full permission to the Bonner Springs-Edwardsville Area Chamber of Commerce, and/or agents authorized by them, to any photographs, videotapes, recordings, or any other record of this event for any legitimate purpose. I further understand that all State and local city Alcohol laws will be enforced.*
